SCHOLARSHIP POLICY AND PROCEDURE

1. Introduction: Naipunnya was started in 2002, with the objective of serving the community around. "To Reach the Unreachable" is the avowed vision of Naipunnya. Thus we at Naipunnya, believe that money should not be a roadblock for a student to pursue his/her passion towards excellence in education. We extend scholarships to meritorious students based on their academic achievements. A number of scholarships are offered to students depending on the academic credentials and their achievements. Till date, Naipunnya has supported students with financial assistance, Scholarships and several job oriented programs. The people around the Naipunnya premises and the community around have benefitted from these programs.

OBJECTIVES OF THE SCHOLARSHIPS

 Scholarships are set up to recognize meritorious students in academics and co-curricular activities

SCOPE The scholarship is to be awarded to students who are meritorious and are selected and notified in a transparent manner by the scholarship committee. It will cover the MBA program of the college.

ELIGIBILITY Students who have 70% or more marks in the final examination or semester examinations are eligible to apply for Scholarships

EARMARKING

- A. Scholarships for Meritorious Students (General):
 - 50% of the scholarships are earmarked for meritorious students of any community.
- B. Scholarships for Meritorious Girl Students (Gender):
 - 25% of the scholarships are earmarked for girl students
- C. Scholarships for Meritorious Catholic Students:
 - 25% of the scholarships are earmarked for Catholic Students

NB: In case of non-availability of students of a particular criteria, it will be transferred to students of other criteria.

NB: The decision of the scholarship committee shall be final and no representation shall be entertained in this regard.

ELIGIBILITY FOR SCHOLARSHIPS/FINANCIAL AID: The Institution encourages all deserving and eligible candidates to apply for the scholarship, if they qualify **for the minimum requirements, which are outlined below:**

- 1. The scholarships are open to all Indian nationals.
- 2. The applicant must be registered for the MBA program at NBS, Pongam with a valid student number given from the college and University registration number
- 3. The applicant must have a minimum of 70% marks in the qualifying exam.
- 4. A scholarship holder under this scheme will not hold any other scholarship/stipend. If awarded any other scholarship/stipend, the student can exercise his/her option for either of the two scholarships/stipends, whichever is more beneficial to him/her and should inform the awarding authority through the Head of the Institution about the option made. No scholarship will be paid to the students under this scheme from the date he/she accepts another scholarship/stipend.
- 5. The scholarship is dependent on the satisfactory progress and conduct of the scholars. If it is reported by the Head of the Institution at any time that a scholar has by reasons of his/her own act of default failed to make satisfactory progress or has been guilty of misconduct such as resorting to or participating in strikes, irregularity in attendance without the permission of the authorities concerned etc., the authority sanctioning the scholarship may either cancel the scholarship or stop or withhold further payment for such period as it may think fit.
- 6. If a student is found to have obtained a scholarship by false statements, his/her scholarship will



- be cancelled forthwith and the amount of the scholarship paid will be recovered from the student concerned and will be blacklisted and debarred for scholarship in any scheme forever.
- 7. A scholarship awarded may be cancelled if the scholar changes the program of study for which the scholarship was originally awarded. The Head of the Department shall report such cases to them and stop payment of the scholarship money. The amount already paid may also be recovered from the student.
- 8. The regulations can be changed at any time at the discretion of the Management of NBS.

PROCEDURE FOR APPLYING

An application for scholarship should comprise:

- 1. One copy of the application for scholarship in the prescribed form (separate application forms as have been prescribed for 'fresh' and renewal scholarship) by the college office.
- 2. One copy of the passport size photograph with signatures of the student thereon
- 3. Copy of Aadhar card
- 4. Mark sheets of previous programmes/semesters completed.
- 5. One attested copy of certificates, Higher secondary/Diploma, etc. in respect of all examinations passed.
- 6. A receipt in acknowledgement of the scholarship in the previous year on the form attached to the application only duly countersigned by the HoD concerned, if the applicant was in receipt of a scholarship under this scheme in the preceding year.
- 7. Recommendation letter from the Parish Priest in case of Catholic students.
- 8. Application complete in all respects shall be submitted to the Executive Director through the Director, of NBS by the candidate.
- 9. For new entrants to MBA Program, UG exam marks, KMAT score, Personal Interview score will be the criteria. In subsequent semesters, student's academic performance (University exam results, or internal assessment result where University exam score is not available), attendance, and score given by OPTS (Overall Performance Tracking System) are the criteria. For subsequent semesters, the eligibility for applying for scholarships includes 70% marks for the final exam and 90% attendance.

Desirable

- Appreciated performance of each applicant on tests or entrance scores designed by the college to measure ability and aptitude for educational work.
- Participation in Extracurricular Activities.
- Expression of thoughts and visible motivation and has demonstrated the following attributes:
 - Positive attitude
 - Encourages others
 - Charitable
 - Hard working
 - Compassionate
 - High moral character
 - Accept rules and regulations of the college
 - Participate in all programs of the college

Other Rules:

- The scholarship will not be combined with any other scheme/promotion at NBS or NIMIT..
- The scholarship amount can be used towards the payment of fees by the applicant, but is not transferable to any other student/person.
- The application for scholarship must be complete in all respects and be submitted on or before the deadline issued by the college.
- The decision made by the scholarship committee of the College will be final and not subject to challenge by the applicants.
- The institution reserves the right to rescind the scholarship from the time it is found that the candidate has deteriorated in academic performance.

- 1. For new applications: Applications are accepted in the month of March and May, and declared in April and June.
- 2. For subsequent semesters, it is accepted from 15th to 30th January, and 15th to 30th July.
- 3. Announcement of Scholarships: 1-15th February and 1-15th August every year.
