ORDER

Provisional Affiliation for starting a new Self-financing Institution, viz. Naipunnya Institute of Management and Information Technology, Pongam, Koratty, Thrissur (Dt.), under the management of Naipunya Charitable Society, Pongam, Koratty, Thrissur, during the academic year 2012-2013 with MBA programme, vide U.O. read as 1st.

- 2. The name 'Naipunnya Institute of Management and Information Technology', Pongam, Koratty, Thrissur, was changed to 'Naipunnya Business School', Pongam, Koratty, Thrissur, vide U.O. read as 2nd above.
- 3. The Continuation of Provisional Affiliation was granted to this programme with an intake of 60 students for the academic year 2022-23 on conditional basis subject to the submission of renewal NOC from the Government for the academic year 2022-23 vide U.O. read as 3rd.
- 4. The Principal has applied for Continuation of Provisional Affiliation to the MBA programme with 60 seats for the academic year 2023-24 vide paper read as 4th, by remitting Rs 1,32,300/- (Rupees One lakh thirty two thousand and three hundred only) towards the administration and affiliation fee.
- 5. Vide G.O. read as 5th, the College produced the renewed NOC for conducting self financing MBA programme with 60 seats for the academic year 2023-24.
- 6. The AICTE has extended its approval to the MBA programme, with an intake of 60 students, in the college for the academic year 2023-24 vide paper read as 5th.
- 7. Considering the above, the Vice Chancellor accorded sanction (i) to grant Continuation of Provisional Affiliation to the MBA programme with an intake of 60 students at Naipunnya Business School, Pongam, Koratty, Thrissur for the academic year 2023-24 on conditional basis subject to the submission of renewal NOC from Government of Kerala for the year 2023-24.
- (ii) making the U.O read 3rd as absolute since the College has produced renewal NOC for the academic year 2022-23.
- 8. Orders are issued accordingly with the following terms and conditions:
 - 1. Affiliation granted is strictly provisional and only for the academic year 2023-24.
 - 2. Selection and admission shall be in accordance with the rules and regulations of the University/Government and the directions issued by the University/Government from time to

time.

- 3. In the light of the directions of the Hon'ble Supreme Court of India in WP (C) 656/1998, the institution should take appropriate measures for prevention of ragging.
- 4. Conduct of University Examinations, including that of S.D.E, is compulsory and binding on all colleges affiliated to the University of Calicut.
- 5. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- 6. Violation of any of the above may lead to the cancellation of affiliation.
