

**Memorandum of Understanding (MoU)**  
**Between**

This MoU made this the 12<sup>th</sup> day of April 2024, between NAIPUNNYA BUSINESS SCHOOL (NBS), PONGAM, KORATTY EAST, THRISSUR, KERALA (under Arch Diocese of Ernakulam - Angamaly) affiliated college of the University of Calicut, having its office at Pongam, Koratty east, Thrissur-680308(hereinafter referred to as 'NBS') through its authorized signatory and APOLLO ADLUX HOSPITAL, ADLUX JUNCTION, KARUKUTTY, ANGAMALY, ERNAKULAM, KERALA 683576, having its office at Karukutty, Angamaly, Ernakulam district.

WHEREAS NBS, Pongam, is an educational body engaged in education and interested to avail medical treatment facility for its Faculty, Students and Staff and WHEREAS Apollo Adlux Hospital is a multi-specialty, hospital providing medical facilities in all the fields and specialties and agrees to provide medical facilities to the employees and students of NBS, Pongam.

Now this MoU witness and it is agreed by and between the parties as follows:

- 1) Apollo Adlux Hospital will extend the following health privileges to the employees and dependents (Father, Mother, Spouse and Children) of NBS.
  - 10% concession for inpatient care on all items excluding Packages, Diet, Devices, Implants, Pharmacy and Consumables
  - Free OPD registration
  - 20% concession on OPD consultation fees (Excluding Visiting Consultants)
  - 15% concession on all in house investigations done as OPD

NBS members/dependents should produce their ID Card/Copy of the ID Card at the time of visit to avail aforesaid corporate concession

- 2) Apollo Adlux Hospital, shall provide medical facility to the students and staff members under emergency situations. Apollo Adlux Hospital will not provide cashless facility. The patient will pay cash and may avail insurance facility for the treatment after discharge.
- 3) Apollo Adlux Hospital shall furnish to NBS, Pongam the Detailed Schedule of Charges for various services and will keep informed about any revision in the charges, which may take place from time to time.
- 4) The NBS, Pongam beneficiary will be provided best possible treatment by the panel of consultants attached to Apollo Adlux Hospital according to the practice parameters and clinical protocols established by Apollo Adlux Hospital.
- 5) Apollo Adlux Hospital will collaborate with NBS to conduct activities such as Medical Camps, Blood Donation Camps, Awareness sessions etc.
- 6) MoU can be terminated by either party by giving one month's prior notice.
- 7) Any clauses in the MoU can be affected as an addendum, after the written approval from both the parties.
- 8) The MoU shall be applicable for one year from the date of agreement.

This MOU shall come into force with effect from 3<sup>rd</sup> day of October 2023 and will remain in force until terminated by either party by giving written notice to this effect. IN WITNESS WHEREOF the parties have hereto signed this Agreement on the date first above written.
