Clause 1

CO-OPERATION

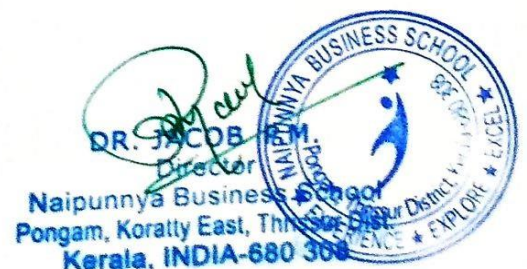


