



## **UGC-NET EXAM**

University Grants Commission National Eligibility Test (UGC NET) or NTA UGC NET is a national-level exam conducted in order to determine the eligibility of candidates for Assistant Professor or Junior Research Fellowship (JRF) and Assistant Professor posts in Indian universities and colleges.

## UGC NET Eligibility 2024 - Educational Qualification

Candidates need to have the following educational qualification in order to be eligible to apply for the UGC NET exam:

Candidates should have secured at least 55 per cent marks in master's degree exams. A relaxation of five per cent is given to candidates belonging to Scheduled Caste (SC)/Scheduled Tribe (ST)/Other Backward Class (OBC)/Persons with Disability (PwD)/Transgender category. Therefore, candidates from reserved categories require only 50 per cent aggregate marks in their master's degree exams.

Candidates should have completed their post-graduation from a UGC recognized college/university in relevant streams such as Humanities, Social Science, Electronic Science, Computer Science & Applications, etc.

Candidates appearing in or awaiting results for their final year examination of master's degree are also eligible to apply online for the UGC NET exam. However, such candidates are admitted provisionally and are considered eligible only when they pass their master's exam with the required percentage. "Such candidates must complete their PG degree examination within two years from the date of NET result with required percentage of marks, failing which they shall be treated as disqualified", informs the official website.

PhD degree holders whose master's exams were completed on September 19, 1991 (regardless of the result declaration date) are eligible for a relaxation of five per cent marks in the aggregate i.e., only 50 per cent marks are required for such candidates.

**UGC NET 2024 Exam:** UGC NET Application Form 2024 for December cycle will be released by NTA on December11, 2024, along with the notification. The National Testing Agency will release the UGC NET notification and applications for the UGC NET 2024 December cycle exam on January1-19, 2025, on the official website. Candidates will be able to fill out the UGC NET Application Form 2024 from November 19 to December 10, 2024. UGC NET official notification PDF and UGC NET. The UGC NET 2024 December cycle will be carried out between 01 January 2025 to 19 January 2025.

The UGC NET notification will comprise details like UGC NET 2024 December application details, eligibility criteria, syllabus, and more. The notification will be released by the NTA explaining the steps to apply for UGC NET December cycle exam 2024. UGC NET application form 2024 comprises five sections that are personal details, educational qualification, Id verification, signature & photo upload, and application fees.

## **UGC NET 2024 Application Form**

The last date for filling out the UGC NET 2024 application form is 19 November 2024 to 10 December 2024.NTA released the UGC NET 2024 application form on 19 November 2024, for the December Cycle 2024 on the official website. The candidates have to fill out the application form online. The application form was made available in online mode. To complete the UGC NET 2024 application process, candidates were required to upload scanned copies of their photographs and signature along with the payment of the application fee.
